## Plant 2 Project Ahead of Schedule

The Plainview Board of Commissioners is pleased to announce that the project is progressing ahead of schedule; originally scheduled to be fully operational in April, Plant 2 is now expected to be completed by this month. The Water District has commenced start-up testing to ensure smooth operation, and looks forward to the unveiling of the upgraded facility.

# Nassau Community College Environmental Science Students Take a Tour of the Plainview Water District

For years, longtime Plainview resident and professor of environmental science at Nassau Community College Ivan Kadar has accompanied his classes on trips to the Plainview Water District. On a recent trip, 12 students from NCC visited the Water District for a presentation on our water supply. Plainview Water District employees taught students about the source, quality and quantity of our water supply and its place in the environment.



Plainview Water District Commissioner Joel Kessler greeted the students and Professor Kadar. Water District Superintendent Paul Granger then provided a 45-minute computer presentation on Long Island's groundwater system. Superintendent Granger also gave a hands-on demonstration of the Long Island aquifer system with the use of a groundwater simulator, which enhanced the students' learning experience through the use of a visual working model.

"The Plainview Water District is always pleased to assist in helping students understand the important role that water plays in the environment. By seeing what our employees do to ensure a safe and healthy drinking water supply, students are given the chance to learn how our water system works," said Plainview Water District Commissioner Joel Kessler. The Commissioners and staff wish these students good luck, and look forward to future visits from Professor Kadar's classes.

Ms. LaRocca's exemplary skills continue to help provide quality water to the Plainview community.


# Plainview Water District Bill Among Lowest Monthly Utilities

## Minimal Rate Increase is First in Four Years

Plainview Water District rates have been held constant for four years, despite increasing costs of energy, major infrastructure protection costs and water quality testing. However, stricter environmental and security regulations, as well as higher water quality standards and Water District capital improvement projects, have resulted in a minimal rate increase for 2007. The new rates, effective January 1, are as follows:

Gallons Used Quarterly	Old Rate	New Rate
Up to 10,000 gallons	\$6.50 minimum	\$7.00 minimum
10,000 to 40,000 gallons	\$1.05 per 1,000 gallons	\$1.15 per 1,000 gallons
40,000 to 100,000 gallons	\$1.30 per 1,000 gallons	\$1.60 per 1,000 gallons
Over 100,000 gallons	\$1.90 per 1,000 gallons	\$2.25 per 1,000 gallons

The average increase for a Plainview-Old Bethpage homeowner is approximately \$15 per year, or about \$1.25 per month. Despite these new rates, the water service still ranks as the least expensive common utility in the Plainview-Old Bethpage area at an average of only \$33 a month. In comparison, the approximate average cost for electricity usage is \$190, while heating costs can run as high as \$230 per month.



The Board of Commissioners of the Plainview Water District is committed to providing its residents with the highest quality and fairly priced water, while ensuring complete compliance with all state and federal environmental regulations.

## How Can You Lower Your Energy Bill?

Well into winter and with oil priced at around \$63 a barrel, you're likely experiencing a significant spike in your energy bill. At this time of year, the largest portion of your energy bill can be attributed to the cost of heating water. By reducing hot water usage, you can expect your monthly costs to decline. Plainview Water District Commissioner Joel Kessler explains, "High energy costs are one of the biggest household concerns each winter. What many people don't realize is that by just taking a few simple steps to reduce hot water usage, we can avoid some unnecessarily high bills." The Board of Commissioners offers these few suggestions:

- ❖ Repair leaky faucets and install devices that regulate and restrict water flow, such as faucet aerators and low-flow showerheads.
- ❖ Opt for a shower instead of a bath; showers require up to a third less hot water than baths.
- ❖ On home appliances, such as washing machines and dishwashers, use the lowest temperature settings available, and only operate these appliances on full loads.
