STEPHEN MORIARTY'S REPORT - SUPERINTENDENT:

Supt. Moriarty reported additional safety and exit lighting is being added to the exterior of the District's administrative building. Several repairs are being conducted where necessary.

Supt. Moriarty reported that response was provided for the previously discussed FOIL request. Supt. Moriarty also reported and discussed details of an additional FOIL request recently received. The District's acknowledgement letter was submitted and the information requested will be provided.

Supt. Moriarty provided the Board with a copy of a letter sent to Pace Analytical Services at the Board's request. Details of the letter were discussed.
